Terms & Conditions for Pursuing Ph.D. (Mathematics) at HRI

- This offer is subject to your passing the M.Sc. Examination with at least 55% aggregate marks, in support of which self-attested copy of the Mark sheet/Provisional Certificate from the concerned University, should be submitted at the time of joining the Institute.
- You will have to undergo a medical examination by the HRI Authorised Medical Consultant, soon
 after joining. You are required to inform the HRI Authorised Medical Consultant your medical
 history and current prescription medicines you are taking.
- 3. You will be entitled to the following as per Institute Rule/Regulations of the Govt. of India applicable to Ph.D. scholars, which may change from time to time.
- (a) As per DAE's O.M. No.10/1(21)2014/Fellowship/R&D-II/2939 dated 06-03-2019 and as amended from time to time, the rates for JRF Fellowship having M.Sc./B.E./B.Tech/ B.VSc/ B.Pharma qualification will be Rs.31000/- p.m. for 1st two years and then Rs.35000/- for subsequent years. The rates for SRF having M.Tech/M.E./ M.V.Sc./ M.Pharma/ M.B.B.S./ B.D.S./M.Sc./B.Tech with two years' experience qualification will be Rs.35000/- p.m. during the fellowship period. The fellowship for the Academic Year 2021-22 will start from 1st January, 2022.
- (b) The tenure and other issues shall be governed in accordance with the DAE's regulation O.M. No. 10/1(21)2014/Fellowship/R&D-II/3943 dated 24-03-2015 and amended from time to time.
